GENERAL RULES

2010

The following rules apply to all exhibit categories:

1. 4-Her must be present to enter exhibit unless other arrangements have been made.
2. Open only to Hardin County 4-H members.
3. Neither the Hardin County Community Fair and Horse Show nor the Hardin County 4-H Council, Inc. will be responsible for any loss or damage to the exhibit, however the utmost care will be used to prevent loss or damage.
4. Exhibit entries which do not meet all of the requirements will be judged and receive a blue, red, or white ribbon, but will not be considered for class champion.
5. **THE DECISION OF THE JUDGES ARE FINAL!**
6. Entries will be accepted Monday, **July 5, 2010** beginning at 10:00 am and ending at 4:00 pm. Exhibits will not be accepted at any other time unless publicized in the 4-H members' newsletter.
7. All exhibits must be picked up between 1:00 - 3:00 am, Sunday, **July 11, 2010**.
8. All class champions, with the exception of food and horticulture exhibits, will be kept for entry in the KY State Fair.
9. Junior ages are 9 - 13; Senior ages are 14 - 19
10. Children under age 9 may exhibit in all classes in the Cloverbud Division. Cloverbuds will receive ribbons, however, they are not eligible for champion or premium.

EXHIBIT CATEGORIES
HORTICULTURE & PLANT SCIENCE
PLANT DISPLAYS

1. You should **NOT** use garden soil in containers. **Use well-drained, disease-free potting soil for all containers.**

- 565 - Terrariums
- 566 - Dish Garden (Desert or Tropical)
- 567 - Vegetable bucket garden (grown in container-not dug out of garden)
- 568 - Annual bucket garden
- 569 - House Plant
- 570 - Hanging baskets

VEGETABLE DISPLAYS

Note: Vegetables will not be returned. All vegetables excluding the fruit and/or vegetable display, must be entered on paper plates supplied by the exhibitor.

- 571 - Fruit and/or vegetable display from the 4-Hers garden. Display must be in an easily movable container 1' x 2' in size.
- 572 - Tomatoes (5 per plate) **Must** be ripe, red or yellow only.
- 573 - Pepper -hot, bell or sweet (any variety, 5 per plate)
- 574 - Cucumbers, slicing or pickling (5 per plate)
- 575 - Beans, Snap or Lima (12 per plate)
- 576 - Corn, Sweet - In husk with silks (5 ears per plate)
- 577 - Cantaloupe - 1 whole, **cut in half**
- 578 - Largest Tomato (by weight) **Must** be ripe red or yellow
- 579 - Largest Cabbage (by weight)
- 580 - Largest Pumpkin (by weight)
- 581 - Largest Watermelon (by weight)

TOBACCO

Information regarding tobacco entries may be obtained by contacting the Hardin Co. Extension Office, 765-4121.

CROPS PROJECT

1. Grain samples must be of good quality and free of foreign matter. The Superintendent has the authority to refuse any and all entries due to excess chaff, rodent pellets, mold, musty, foreign materials, or anything that makes it unsuitable for display. Do not bring grains in glass containers. **Grain must be in one (1) gallon zip-lock bags. ID tags and yield/variety information must be attached to bag.** Neither the container nor the grain will be returned.
2. A Legume hay shall consist of 85% of the class designed legume. Grass hay shall be 85% of the class designed grass. Mixed hay should contain only one eligible grass and one eligible legume. The legume component shall be at least 30 percent alfalfa and not more than 70% legume. Eligible legumes are alfalfa, red clover, and ladino clover. Eligible grasses are timothy, Bermuda grass, orchard grass, tall fescue and rye grass.
3. **Roots of soybeans must be washed.**
4. **Bring 1/2 hay bale - place hay bale securely bound with cord or twine in a large double strength garbage bag. **Tags must be attached to the bale and not the bags.****

LEGUME HAY:

- 600 - Alfalfa Hay, *1/2 bale (no full bales accepted)* from the current year's project crop, neatly tied and labeled. **Place hay in a double strength plastic bag.**
- 601 - Red Clover Hay, *1/2 bale (no full bales accepted)* from the current year's project crop, neatly tied and labeled. **Place hay in a double strength plastic bag.**

GRASS HAY:

- 602 - Timothy Hay, *1/2 bale (no full bales accepted)* from the current year's project crop, neatly tied and labeled. **Place hay in a double strength plastic bag.**
- 603 - Other Grass Hay, *1/2 bale (no full bales accepted)* from the current year's project crop, neatly tied and labeled. **Place hay in a double strength plastic bag.**

MIXED HAY:

- 604 - Mixed Hay, *1/2 bale (no full bales accepted)* from the current year's project crop, neatly tied and labeled. **Place hay in a double strength plastic bag.**

YELLOW CORN:

- 605 - Yellow-ear, from previous year's crop, 8 ears shucked, and **labeled with variety and yield.**
- 606 - Yellow-ear, from current year's crop, 8 ears shucked, and **labeled with variety and yield.**
- 607 - Yellow-shelled, from previous year's crop, 0.5 gallon in a container, and labeled with **variety and yield.**

WHITE CORN:

- 608 - White-ear, from the previous year's crop, 8 ears shucked, and **labeled with variety and yield.**
- 609 - White-ear, from the current year's crop, 8 ears shucked, and **labeled with variety and yield.**
- 610 - White-shelled, from the previous year's crop, 0.5 gallon in a container, and **labeled to show variety and yield.**

POPCORN:

- 611 - White Popcorn-ear, from previous year's crop, 8 ears shucked, and labeled with variety and yield.
- 612 - Red Popcorn-ear, from previous year's crop, 8 ears shucked, and labeled with variety and yield.
- 611 - Yellow Popcorn-ear, from previous year's crop, 8 ears shucked, and labeled with variety and yield.

FIELD SOYBEANS (Oil):

- 614 - Soybeans from the current year's crop, three stalks tied together below leaves with roots intact, but free of soil, labeled to show variety.
- 615 - Soybeans from the previous year's crop, 1 gallon zip lock bag, and labeled with variety and yield.

GRAIN SORGHUM (Milo):

- 617 - Grain Sorghum from the current year's crop, three stalks tied together below leaves, with roots intact, but free soil, and labeled to show variety.
- 618 - Grain Sorghum from the previous year's crop, 1 gallon zip lock bag, and labeled to show variety and yield.

SWEET SORGHUM:

- 619 - Sweet sorghum from the current year's crop, three stalks tied together below leaves, with roots intact, but free of soil, and labeled to show variety.

WHEAT (Soft, Red Winter):

- 620 - Wheat from the current year's crop, 0.5 gallon in a container, and labeled to show variety and yield.
- 621 - Barley from the current year's crop, 0.5 gallon in a container, and labeled to show variety and yield.

ELECTRIC

1. Exhibits must be made according to the instructions in the 4-H project book.
2. All exhibits requiring bulbs must have the correct bulb.
3. No cord that has been purchased and later repaired may be entered.
4. Effective strain relief should be provided for all wire to terminal connections. Knots, clamps, connectors, or staples are acceptable when used appropriately
5. Only 1 entry per 4-H member

- 645 - Battery Powered Series and Parallel Circuits
- 646 - Electric games
- 647 - Electromagnetic circuits
- 648 - DC motor

WIRING - AC Power, Unit 3

- 649 - Electric extension cord - (3 wire), heavy duty outdoor.
- 650 - Wiring diagram for home and/or farmstead
- 651 - Wiring Display - actual wiring for a special unit

LIGHTING - Not covered in new material

- 652 - "Pop can" lamps
- 653 - Table, desk, vanity, or floor lamps (any purpose - kits only)

- 654 - Pin Up lamp - assembled from kit, or original

WOOD SCIENCE

1. Reference materials include the KY 4-H Wood Science Plans Notebook & the 4-H CCS Woodworking Wonders Guides.
2. **Only 1 entry per 4-H member.**

- 674 - **Level 1 made from a kit.** Simple items which **have pre-cut and pre-drilled parts and youth** demonstrate knowledge of **assembly**, selection and use of fasteners (nails, screws and/or glue), sanding techniques, and appropriate finishes. (Ex. Small Bird House, Non Hopper Birdfeeder).
- 675 - **Level 1 Not made from a kit.** Simple constructed wood item showing knowledge of hand tools, wood selection, **cutting, drilling** and use of fasteners (nails, screws and/or glue), sanding techniques, and appropriate finishes, (such as **small** napkin holder, letter holder, **simple** picture frame, wire wiggley, towel holder, serving tray, jewelry box, **small** flag holder, 4-H book ends, airplane, hurricane lamp, trivet (pot holder), etc).
- 676 - **Level 2, from a kit.** More elaborate items which require cutting, drilling and youth demonstrate knowledge of selection and skill in use of fasteners (nails, screws and/or glue), sanding techniques, and appropriate finishes (Example: pine wood car, large bird house)
- 677- **Level 2, not from a kit. More elaborate** items that demonstrate a mastered skills with hand tools, basic knowledge of power hand tools, fastening options, appropriate surface preparations, and finish applications, (such as **puzzle**, foot stool, revolving tie rack, 4-H key holder, cutting board, book rack, serving dish shelf, sawhorse, hopper type birdfeeder etc.)
- 678 - **Level 3, not from a kit.** Items showing a more advanced knowledge of power tools, expertise in cutting, fitting, surface preparation, attention to fastening details, and finish application, (such as a multi-purpose box, corner shelf, book shelf or laminated wood projects, garden bench, planting box, nail and tool box, shop tool rack & shelf, etc.)
- 679 - **Level 4, No kits.** Exhibits with a "furniture" quality finish, showing an understanding of all woodworking techniques learned in previous levels. Items showing mastery of joint construction, use of **special** woods, and finishes. (Examples, check board, room divider, coffee table, end table, chest of drawers, gun **rack** or cabinet, etc.
- 680 - **Level 4, No kit.** Exhibits that do not have a fine finish **painted finish allowable**) because of practical use. Items demonstrated knowledge of all woodworking techniques in previous levels. Items showing mastery of **cutting, drilling**, joint construction, use of **special** woods, and appropriate finishes. (Examples, porch swing, chaise lounge, picnic table, lawn chair, **large planters**, etc.)

ENTOMOLOGY

Any 4-H youth participating in any of the Entomology projects may still enter their project work in the Hardin County Fair. Qualifying entries will be displayed and judged on the Danish system. Qualifying entries will be eligible to be entered at the State Fair. For more information regarding eligible entries you may contact the Hardin county Extension Center, (270) 765-4121.

4-H ARTS & CRAFTS

1. Drawings and paintings must be matted or framed with attached hanger. (Wire hangers attached to the frame for paintings and drawings only). **No wire hooks taped to back. All hangers must support the weight of item.**
2. Entries must be accompanied by an information card for 4-H Arts & Crafts and 4-H Identification Card.
Each Exhibitor may enter only Two (2) classes in Section A and only 2 classes in section B for a maximum of 4 entries in the arts division per 4-H'er
3. Exhibits will be disqualified if:
 - a. **Pictures or other hanging items do not have an attached hanger. No wire hooks taped to the back. (Wire hangers must be secure and attached to the frame for paintings and drawings. All hangers must support the weight of the item.)**
 - b. **Pictures are not mounted on firm matt and/or framed, with attached hanger.**
 - c. **Entries are not labeled as to whether they are an original design, made from pattern, or made from a purchased kit.**
 - d. **If subject matter is not “family friendly”.**
 - e. **Drawings and paintings must be framed. Plexiglas is preferred over glass.**
4. Small items, which are easily separated or destroyed, may be placed in small plastic bags. For items with more than one piece, a description on the back of the ID card is suggested with number of pieces, color, description, etc

Horse Craft Contest

In order to align Horse Crafts so that they are also eligible for **county/state fair** categories, several changes have been proposed along with a few new guidelines. Some of the new guidelines are just a part of the specifics required for **county/state fair**. *In order to be in absolute alignment with county/state fair categories and guidelines, be sure to consult your Extension Office and the county/state fair book.*

- 1.) The craft divisions will continue to be divided into two categories based on age of the 4-H member as of January 1 of the year the contest is held:
 - Junior Division-9-13 years old
 - Senior Division-14-18 years old
- 2.) All craft articles, regardless of division, must in some way relate to the horse.
- 3.) Contact your Leader for complete Sate Horse Contest rules.

SECTION A:

- 727 - Junior Jewelry Beadwork- One piece of jewelry created by youth. **No kits or pony beads allowed.**
- 728 - Senior Jewelry Beadwork – One set (at least two items) of jewelry created by youth. **No Kits or pony beads allowed.** Example: earrings and necklace; bracelet and necklace.

- 729 - Junior Folk Art – One Items that has paint for a decorative or craft purpose. **No Clothing.**
- 730 - Senior Folk Art- same as above
- 731 - Junior Weaving-.Items that are made through various weaving techniques. **One pair of place mats, pot holders(pair) or one small wall hanging. No Plastic materials allowed. Wall hangings must be mounted and be ready for hanging. Baskets are not included.**
- 732 - Senior Weaving- One item (**only one item is permitted for entry**);rug, belt, stool with woven seat, or wall hanging item made through various weaving techniques using mixed media fibers, no plastic materials allowed, **Baskets are not included. Wall hangings must be mounted and be ready for hanging.**
- 733 - Junior Nature Crafts- Item made from natural materials. **No kits allowed. If wall hanging or wreath, items** must include wire or hooks and be ready for hanging
- 734 - Senior Nature Crafts- Wall wreath, or hand carved native materials made from natural materials only. **No kits allowed.** Must include wire or hooks and be ready for hanging.**(not other items allowed)**
- 735 - Junior Basket Making - Natural materials, any size, shape, or design. Non-natural materials may be woven into the design.
- 736 - Senior Basket Making- same as above
- 737 - Junior Leather Craft- Item made from leather. May or may not be tooled. Kits allowed.
- 738 - Senior Leather Craft- Same as above. **No kits allowed.**

The following rules apply to all ceramic classes:

1. Original design ceramics will be accepted in that class only. It will not be accepted in glazed or stained classes.**(All Ceramics Must Be Fired)**
 2. **Small items, which are easily separated or destroyed, should be placed in small plastic bags. For items with more than one piece, a description on the back of the ID card is suggested with number of pieces, color, etc.**
- 741 - Junior Original Design Ceramics - original item made from clay using a process of casting, hand molding, or a potter's wheel.**(All Ceramics Must Be Fired)**
 - 742 - Senior Original Design Ceramics - same as above.**(All Ceramics Must Be Fired)**
 - 743 **Junior Ceramics – Item that is pre cast and has been fired.**
 - 744 **Senior Ceramics – Item that is pre cast and has been fired.**
 - 745 **Junior Scrapbooking – One scrapbook page including 2-4 pictures. Page must include captions or journaling. Page must be placed in a plastic page protector.**
 - 746 **Senior Scrapbooking – One scrapbook page including 2-4 pictures and embellishments (ie. Stickers, lettering, designs). Page must include captions or journaling. Page must be placed in a plastic page protector.**
 - 747 **Junior Decoupage – Any item using the decoupage process. If appropriate, must use wire or hook to be ready for hanging.**
 - 748 **Senior Decoupage – same as above.**
 - 749 **Junior. Paper Crafts – Item made from any source of paper including but not limited to: stamping, handmade note card, brown sack lunch bag scrapbook, gift box, etc.**
 - 750 **Senior Paper Crafts – same as above.**

All drawings and paintings must be mounted on a sturdy background (mat board) and framed, ready to hang with secured hangers on the frame (wire hangers).

- 751- Junior Acrylic/Oil Painting - items that are made through the process of painting on paper or canvas, using any media of paints (oil, acrylic). Paint by number will be disqualified. No kits, original work only.
- 752 - Senior Acrylic/Oil Painting - same as above
- 753 - Junior Watercolor Painting - items made through the process of painting on paper or canvas, using any watercolor process.
- 754 - Senior Watercolor Painting - same as above
- 755- Junior Color Drawing - items made through the use of drawing lines using pen, pencil, pastel, charcoal, markers or chalk.
- 756 - Senior Color Drawing - same as above
- 757- Junior Black and White Drawing - items made through the use of drawing lines using pen, pencil, charcoal, markers or chalk. No additional colors added.
- 758- Senior Black and White Drawing - same as above.

PHOTOGRAPHY

1. Specifications for exhibits:
2. **(Those not meeting specifications listed below will be disqualified)**
 - a. **All pictures must be made since the last State Fair.**
 - b. Photos may be either Black & White or Color unless otherwise stated.
 - c. Digital images may be submitted in all classes, unless otherwise stated.
 - d. **ALL CLASSES (including Horticulture) WITH ONE PHOTOGRAPH MUST BE MOUNTED ON 10"x 16" MAT BOARD-available via order entry (**no poster board or foamcore board accepted**). Single photographs are limited to maximum size of 8"x 12".**
 - e. **ALL CLASSES (including Horticulture) WITH MULTIPLE PHOTOGRAPHS (MORE THAN ONE PHOTOGRAPH) MUST BE MOUNTED ON 16" x 20" MAT BOARD (**no poster board or foamcore board accepted**).**
 - f. Each picture must be mounted securely. Rubber cement or dry mounting tissue is recommended. **DO NOT** use photo mounting corners.
 - g. Pictures may be cropped (trimmed).
 - h. Absolutely nothing on front of mat board. Any other required materials are to be mounted on the back.
 - m. **All photographic entries are required to have sticky-back Velcro ("hook" Velcro only) in each of the four corners on the back of the mat board for easier exhibiting. The "loop"/smooth Velcro is not necessary and leaving it off will minimize hanging preparation time by judges.**
3. Photography will be judged on, but not limited to: Technical, impact, composition, creativity, presentation, sequence or collection.

In General Photography (levels 1 & 2), 4-H'er can enter only 3 classes within one level per year (includes classes 760 thru 778).

LEVEL I:

Purpose of this level is to promote Life Skills in the area of Communication, Workplace Competencies, and Foundation Skills through photography.

- 760 - Single Photograph: **A personal interest as the main focus of the picture** – 10”X 16”
- 761 - Sequence of three photographs: **A A personal interest as the main focus of the picture** – 16”x 20”
- 762 - Single Photograph: subject: **STILL LIFE as the main focus of the picture**(arrangement of inanimate objects. Definition of inanimate: **nonliving things; something that never was alive, like a rock, buttons, a collection of toys, etc.)**
- 763 - Single Photograph: Animal **as the main focus of the picture** – 10” X 16”
- 764 - Collection: Three different points of a view of the same subject - 16” X 20”
- 765 - My Community: Single Photograph of an interesting building within your community. – 10”X16”
- 766 - Five photographs of an event. Attach a description of the event. – 16” X 20”

LEVEL II:

Purpose of this level is to promote Life Skills in the area of Communication, Workplace Competencies, and Foundation Skills through photography.

- 770 - Five photographs showing movement – 16”X20”
- 771 - Single photograph: Person **as the main focus of the picture** (photographic portrait of an individual) – 10” X 16”
- 772 - Single photograph: subject: Landscape **or seascape as the main focus of the picture** [definition of a landscape: a picture representing a view of natural inland scenery (a portion of land which the eye can comprehend in a single view, including mountains, rivers, lakes, and whatever the land contains--trees, flowers, grasses,) **or seascape ie. ocean**]
- 773 - Collection: Three to Five photographs of the same subject – 16” X 20”
- 774 - My Community: Single photograph (your choice of subject) within your community. – 10” x 16”
- 775 - My Community: Tell a story about your community with 3-5 photographs
- 776 - My Community: Collage of photographs, mounted on 16” X 20” mat board, unlimited number of photographs, size of photographs limited to minimum 3.5” X 5” and maximum 8” X 10”, on the subject of “My Community”. – 16”X 20”
- 777 - Digital Collage: multiple images cropped, resized and combined into one digital image 8” X 10” print (recommended 200-300 dpi). – 10” X 16”
- 778 - ****Digital Illustration:** - Single heavily edited 8” x 12” digital image. Image has been radically digitally edited or enhanced. Modifications may include: cropping, sharpening or blurring, brightness or contrast changes, addition to or the removal of parts of the image, changes in the color scheme of the image, the use of filters or effects. **Attach to back of mat board:**
 1. A page describing editing technique(s) used.
 2. A print of the ORIGINAL image.

HORTICULTURAL PHOTOGRAPHY EXHIBITIONS

NJHA Contest: Entries in the following classes may also participate in the National Junior Horticulture Association Photography Exhibition. It is the responsibility of the individual to submit all required entry forms and follow all rules set out by NJHA organization to participate. States are not limited in the number of entries. See web site for details: www.njha.org

HORTICULTURAL PHOTOGRAPHY CLASSES

- 780 Single black and white. Horticultural subject or activity. (maximum size: 8” x 12”)
- 781 Single color. Horticultural subject or activity. (maximum size: 8” x 12”)

- 782 Sequence of 4 photographs. B&W or Color representing a horticultural event or activity that tells a visual story, chronologically, without the use of words.
- 783 Horticulture collection (B&W or color), consisting of 6 photographs.

A Class Champion will be named in each class.

A Grand and Reserve Champion will be selected from class champions in Horticulture Photography.

SEWING

1. **A member may enter only one class in the Sewing Division.** (This means: a member's name should appear only one time on the county's Sewing Division invoice sheet.)
2. Send NO additional accessories or undergarment with any sewing entry.
3. Items must be "handmade"; no ready-to-wear/factory made items will be accepted for judging. An item accepted that does not meet the class requirements will be judged, but will not be considered for class champion. **Creative Expressions & Wearable Art project must be accompanied by documentation. An entry without documentation will be disqualified.**
5. The definition of a "complete outfit" is an item or items that cover the top and bottom of the body. To be considered a top, a jacket or robe it must include a front closure. Open front tops that require an undershirt do not count unless the under shirt is also constructed.

JUNIOR (4-H AGES 9 - 13) BEGINNING SEWING:

UNIT I - LET'S LEARN TO SEW – *Entry-level exhibit must be made from woven fabric and include straight machine stitching, appropriate seam finish, and a casing or machine stitched hem.*

790 - **Clothing Option:** Shorts, pants, or skirt with casing waistline (elastic and/or drawstring).

791 - **Non-Clothing Option:** **Drawstring tote bag, purse, or laundry bag with drawstring or fabric handles OR a laundry bag.**

UNIT II – LET'S GET TO THE BOTTOM – *Exhibit must be made from woven fabric and must have enclosed seams, appropriate seam finish, interfacing, and zipper.*

792 - **Clothing Option:** Skirt, shorts or pants with zipper and a waistband or facing.

793 - **Non-Clothing Option:** Tote bag, purse, garment bag or gym bag with zipper and self-fabric straps or handles.

UNIT III – TOP IT OFF – *Intermediate level exhibit must be made from woven fabric and include buttons and buttonholes, may include a simple lining, trim, collar, and sleeves.*

794 - **Clothing Option:** Shirt, simple jacket, one piece dress with no waistline, cape with a hood or collar, bathrobe, or vest with lining or facing. Project must include buttons and buttonholes.

795 - **Non-Clothing Option:** Backpack with lining, applied trim, and button/buttonhole closure.

UNIT IV – STRETCH YOUR KNIT SKILLS – *Intermediate level exhibit must be made from a knit fabric with limited amount of stretch may include rib knit for trim only.*

796 - ONE or TWO Piece complete outfit such as a dress, top and bottom, pajamas, or night shirt.

UNIT V – PUT IT ALL TOGETHER – *Advanced level exhibit combining previously learned and newly acquired skills to construct a coordinating ensemble.*

797 - **Clothing Option:** TWO or THREE piece complete coordinating outfit; such as a warm up suit; dress with jacket or coat, swimwear with cover-up, jacket or shirt with slacks/shirt. At least one piece must include sleeves and a collar/hood. No simple casings. Fabric choice may be woven, knit or a combination of the two.

798 - **Non-Clothing Option: Original** Original design tote bag and **documentation folder** Using Wild Ginger Software, Inc. *Wild Things!* Software program, select the Tote Bag option and design a bag that require at least 2 pockets. **Be creative with your design. Required elements: at least 2 pockets;** minimum size of 12 inches in height and 12 inches in width.

At **least one functional zipper**; and creative stitchery or applied trim to personalize your bag. Optional elements: lining, other type closure as design dictates [button(s), hook and loop tape, or snap(s)]. If bag is not lined, it is suggested that the seam allowances be finished with a bound seam finish. **In the documentation folder include: a completed Sewing Project Card,** The printed design sheets (one for each pocket selected) from the program and answers to the following questions:

SENIORS (AGES 14 - 18):

INTERMEDIATE SEWING – LEVEL 1:

LETS BE CASUAL:

799 - **Clothing Option:** ONE or TWO piece complete casual outfit made from knit or woven fabric such as a dress, top and bottom, simple pajamas, or robe.

800 - **Non-Clothing Option:** TWO coordinating fashion accessories from the following: wallet, garment bag, purse, backpack or duffel bag. At least one piece must have a zipper.

DRESS IT UP:

801 - ONE or TWO piece complete Dressy outfit, such as a dress, suit, pantsuit, sport coat and slacks. Fabric choice may be woven, knit or a combination of the two.

MATCH IT UP:

802 - **Clothing Option:** Choose at least (1) one item from each group to make a complete 3 or 4 piece coordinated outfit:

- Shorts, pants, or skirt
- Top, blouse, shirt

- Vest, jacket, sweater

At least one piece is required to have regulation set in sleeves. Fabric choice may be woven, knit or a combination of the two. An accessory item may be included as the fourth piece.

- 803 - **Non-Clothing Option:** THREE or FOUR piece coordinating luggage/travel accessories set. Each piece must have an applied border/trims, pocket and zipper.

CREATIVE EXPRESSIONS:

- 804 - Clothing Option: Construct a complete outfit for one of the following activities:

- Halloween, theater, or historic costume
- Uniform for medical, cheerleader, dancer, etc.
- Riding Apparel

Additional Documentation is required. Include the following: Purpose for the garment, reason for choosing, and any alterations made to individualize the pattern.

- 805 - Non-Clothing Option: Select one of the following and construct a:

- Fabric doll or animal with a wardrobe of two outfits.
- Machine appliquéd specialty flag or decorative banner (minimum size 24" X 24").

Additional Documentation is required. Include the following: Purpose for the item and reason for choosing. If a flag/banner is chosen, include design plan/drawing.

ADVANCED SEWING – LEVEL 2: For youth ages 14-18 with advanced skills

LEISURE TIME:

- 806 - Clothing Option: TWO or THREE piece complete outfit. Chose from the following:

- Athletic wear such as leotard, cycling wear, warm up suit, bathing suit and cover-up, tennis wear
- Pajamas and robe (must use specialty fabric) such as terry cloth, flannel, fleece, nylon tricot)
- Raincoat and hat or rain suit

- 807 - Non-Clothing Option:

- Kite (minimum size 2ft X 3ft)

FORMAL AFFAIR:

- 808 - ONE or TWO piece complete outfit, such as a prom dress, bridesmaid dress, or tuxedo. Fabric choice may be woven, knit or a combination of the two.

TAILOR MADE:

- 809 - Suit, jacket, or coat, made from 100% wool or a least 60% wool blend fabric. Traditional or speed tailoring techniques must be used to create structure in the area of the neck, shoulder, and hemlines. **Do not include none-wool/ wool blend coordinates.**

WEARABLE ART:

- 810 - A complete sewn outfit consisting of 1 to 3 pieces. Garment pieces may include dress, vest, jumper, jacket, pants, skirt, or blouse/shirt. At least on piece must include some sort of fabric manipulation or embellishment. In addition, coordinating accessories may also be included such as hats, scarves, ties, or shawls. If accessories are included they must also include embellishment. ***Additional Documentation is required.*** Include how the design was created, time involved, and any design drawings that were used in the creation.

NEEDLEWORK

Each category (division) will be broken down into the following classes:

Young Junior-----Age 9 to 11

Beginner-----Age 12 and above; refers to skill level

Intermediate-----Age 12 and above; refers to skill level

Advanced-----Age 12 and above; refers to skill level

1. A member may enter one class per category (categories are crochet, knitting, tatting, embroidery, needlepoint, and quilting) in the Needlework Division. (This means: a member's name may appear only one time under each category on the county's Needlework Division invoice sheet.)
2. Items entered must be completed by member within the current project year.
3. **Additional** Documentation **may** be required. Refer to the specific project for details.
4. A copy of the pattern(s) used must accompany project if pattern is not from the Kentucky 4-H Needlework Notebook. Please label pattern with entrants name and county.

CROCHET

- 813- Young Junior: **Here We Go, Row by Row!** (age 9 to 11)
Exhibit one item using single or double crochet stitches with plain medium weight yarn.
Options include: scarf, purse, belt, or hat.
- 814- Beginner: **Here we Go, Around and Around!**
Exhibit one item or single pair of items, or set using single and/or double crochet stitches. May use yarn other than plain medium weight. May include increase/decrease stitches. Options include: purse, scarf, vest, shawl, small afghan, lap wrap.
- 815- Intermediate: **Here we Go, Patterns Galore!**
Exhibit one item, pair of items using intermediate skills and one or more pattern stitched. May include increase/decrease stitches. Can include one or more colors in alternating rows (stripes). Suggested items include: sweater, vest, shawl, mittens, hat, baby blanket, set of 5 ornaments (made with bed-spread-weight cotton thread.)
- 816- Advanced: **From There to Here, Anything Goes!**
Exhibit one item or pair of items that include advanced skills Advanced skills listed in the project guide are: afghan stitch, beadwork, camel crochet, filet crochet, Irish crochet, Kro-knit/Hook, Kro-tat, Hairpin Lace, or broomstick lace. Combining pattern stitches with crocheted buttons and/or buttonholes, creating plaids, geometric designs or checks, making novelty crochet articles such as embellishing pillowcase hems or creating your own design. Original designs must include a copy of directions, notes and diagrams used to create the items(s). . Suggested items include: sweater, jacket, coat, multi-colored hat, purse, collar (made with bedspread weight cotton thread).

EMBROIDERY

All **embroidery** projects are to be a completed item (examples: framed piece, pillow, wall hanging, pot holder, eyeglass holder, etc.) or can be created on a purchased item. (Examples: pillowcase, clothing, toe bag, purse, bib, dishtowel, etc.) Items may be made from purchased kits that meet the individual project guidelines.

817- Young Junior: **Begin Embroidery**(ages 9-11)

Exhibit one of the following:

- Item of red work (red floss on white or unbleached plain woven fabric). Must include stem stitch and have a **minimum embroidered area of 4 x 4 inches**.
- Item of cross stitch on ¼ inch gingham and have a **minimum embroidered area of 4 x 4 inches**.
- Item of cross stitch with stamped design on plain woven fabric and have a **minimum embroidered area of 4 x 4 inches**.
- Item with a cross stitch border design on plain woven white fabric that has a **minimum embroidered area of 2 x 8**.

818- Beginner: Embroidery 101

Exhibit one of the following:

- Item of red work (red floss on white or unbleached plain woven fabric). Must include Stem stitch and have **minimum embroidered area of 5 x 7 inches**.
- Item of cross stitch on ¼ inch gingham and have a **minimum embroidered area of 5 x 7 inches**.
- Item of counted cross stitch on 11 or 14 county Aida cloth and have a minimum embroidered area of 3 x 3 inches.
- Item of cross stitch with a stamped design on white plain woven fabric and have a **minimum embroidered area of 5 x 7 inches**.
- Item with a cross stitch design on plain woven white fabric that has a **minimum embroidered area of 2 x 16 inches**.
- Item of Candlewicking on plain woven fabric. Must include colonial knots and have a **minimum embroidered area of 7 x 7 inches**.
- Item of free embroidery on plain woven fabric or felt. Must include 5 of the following different stitches (stem/outline, lazy daisy, running, straight, French knot, satin, blanket, chain, back stitch). *Must use 3 or more colors of floss* and have a **minimum embroidered area of 5 x 7 inches**.
- Item of snowflake embroidery (Chicken Scratch) on ¼ inch or smaller checked gingham. Must have a **minimum embroidered area of 5 x 7 inches**.

819 Intermediate: **More Embroidery 201**

Exhibit one of the following:

- Item of free embroidery on plain woven fabric. Must include a minimum of 6 different embroidery stitches, with *3 or more colors of embroidery floss*. Must have **minimum embroidered area of 7 x 9 inches**.
- Item of counted cross stitch on 14 count Aida cloth or other fabric using waste canvas. Must have a minimum embroidered area of 5 x 7 inches
- Item of huck embroidery on huck toweling creating a **minimum 2 inch wide border design**.
- Item of crewel embroidery on linen or cotton twill fabric using crewel or Persian yarn. Must have a minimum embroidered area of 6 x 8 inches.

820 **Advanced: Creative Embroidery 301**

Exhibit one of the following:

- Item of counted cross stitch on smaller than 14 count even weave or Aida cloth. Must have a **minimum embroidered area of 5 x 7 inches**..
- Item created or embellished with silk ribbon embroidery using 5 or more embroidery stitches with silk ribbon. Design may also include embroidery floss
- Item constructed of irregularly shaped fabric pieces embellished with a combination of ribbon work, specialty thread, embroidery stitches, and/or beadwork creating a finished crazy quilt design.

KNITTING:

821- **Young Junior: Learn to Knit (ages 9-11)**

Exhibit one item or pair of items using plain medium weight yarn. Solid color or variegated yarn is acceptable. Items are limited to those that include garter stitch, stockinette stitch, and/or ribbing stitch. Suggestions include: slippers, mittens, hat, pillow, purse or scarf. **Machine and loom knitting are not acceptable as hand knitted projects.**

822- **Beginner: Knit One, and Purl too!**

Exhibit one item or pair of items. May use yarn other than plain medium weight yarn. Two colors and one pattern stitch may be used in addition to garter stitch, stockinette stitch, and/or ribbing stitch. Suggested items include: hat, mittens, pillow, purse, scarf, slippers, small afghan/shawl. **Machine and loom knitting are not acceptable as hand knitted projects.**

823- **Intermediate: Keep on Knitting!**

This project focuses on shape .Exhibit one item or a pair of items using pick up stitches, multiple color changes (stripes or duplicate stitch), and/or circular knitting. **Item must include increase or decrease.** May use yarns other than plain medium weight yarn. Suggested items include: gloves, hat, mittens, socks, sweater, or vest. **Machine and loom knitting are not acceptable as hand knitted projects.**

824- **Advanced: Knitter's Choice**

This project focuses on texture aid design. Exhibit one item or a pair of items using charted designs or design your own. Chartist designs may include color changes such as Fairisle knitting or multiple pattern stitches such as Aran Isle knitting or lace knitting. Knitting with beads is also acceptable. **Original designs must include a copy of directions, notes, and any diagrams used to create the item.** Suggested items include: afghan (minimum size 45-x 60-inches), holiday stocking (minimum 18-inches in length), purse, socks, sweater. **Machine and loom knitting are not acceptable as hand knitted projects.**

LACEWORK - TATTING

825 **Young Junior: Learn to Needle Tat** –(ages 9-11)

Exhibit one of the following items using Size 3 tatting needle and No. 3 cotton crochet thread: hand towel with edging, pillowcase with edging, or handkerchief with edging (motif made with stitches which are repeated). Item should include rings with picots and double stitches only.

826 **Beginner: Just a Needle Tatter** –

Exhibit one of the following items using Size 5 tatting needle and **No.-10** cotton thread or cotton crochet thread: hand towel with edging, pillowcase with edging, or handkerchief with edging (motif made with stitches which are repeated). Item should include rings with picots and double stitches only.

827 **Intermediate: Just a Ball and Needle** –

Exhibit one of the following items using size 5 needle and 2 appropriate sized threads: Bookmark, jewelry, embellishment on clothing or other item. Item must include chains and rings with picots and double stitches, may use one or two colors of thread.

828 **Advanced: Tatting and a Little More** –

Exhibit one of the following items:

- Item of shuttle tatting using size 20 or 30 tatting thread. Options: Bookmark, jewelry, embellishment on clothing or other item. Item must include chains and rings with picots and double stitches, may use one or two colors of thread.
- Item of needle tatting using size 7 needle and appropriate sized tatting thread. Options: Bookmark, jewelry, embellishment on clothing or other item. Item must include chains and rings with picots and double stitches, may use one or two colors of thread.
- Item using either shuttle or needle tatting with the use of two threads and beads. Options: jewelry, advanced motif as embellishment on clothing or other items.

NEEDLEPOINT

Young Junior: 9-11 year olds may *exhibit their work in the beginner, intermediate, or advanced level.*

828- **Beginner: Get to the Point**

Exhibit one of the following: item with minimum **finished size of 5-inches square**, pin cushion using tent stitches and two or more colors, or purchased kit meeting project guidelines.

829- **Intermediate: A Stitch at a Time**

Exhibit one of the following using three or more colors: personalized (name or initials) belt, 9-inch square (minimum finished size) sampler using a minimum of four decorative stitches one of which may be a tent stitch – can be framed or finished as a pillow, patterned pin cushion (6-inch square minimum finished size), or purchased kit meeting project guidelines.

830- **Advanced: Patient Stitching Block by Block**

Exhibit one of the following items using three or more colors: 12-inch square (minimum size) item using 4-H design or design of your choice with tent stitch and one or more decorative stitch(es), sampler using a minimum of 6 stitches (Project may be finished into a pillow, a foot stool, chair seat, framed as a picture or other item of choice.), or purchased kit meeting project guidelines.

QUILTING –

All projects are to be a completed item that includes a pieced top, batting, backing fabric, and a finished outer edge. Quilting on long arm quilting machines or hooped embroidery machines is not an option for the Needlework-Quilting project. Quilting or tacking should be done by hand or with the use of a conventional sewing machine.

832 **Young Junior: Patchwork Block –**

Exhibit one 12 inch by 12 inch four-block “quilt” that includes at least two 6-inch square pieced blocks made with square and/or rectangle pieces (straight of grain edges, no bias or triangle pieces). Attach a completed Needlework Project Card to the exhibit with a safety pin.

Quilting technique: machine tack or hand tie. **Finished maximum size is 12”x12”.**

Options for finishing edges: 1) sew and turn right side out, 2) fold edges to inside and stitch close to edge, 3) stitched and frayed or clipped, or 4) self binding by folding backing over the front – squared corners are acceptable.

833 **Beginner: Patchwork Runner –**

Exhibit a 1 x 3 four-block runner “quilt” with a finished size of 12 inches by 36 inches. Each four-block needs to include at least two 6-inch square pieced blocks made with square and/or rectangle pieces (straight of grain edges, no bias or triangle pieces). Attach a completed Needlework Project Card to the exhibit with a safety pin.

Quilting technique: machine tack or hand tie.

Options for finishing edges: 1) sew and turn right side out, 2) fold edges to inside and stitch close to edge, 3) stitched and frayed or clipped, or 4) self binding by folding backing over the front – squared corners are acceptable.

834 **Intermediate: Lap Quilt/Quilted Wall Hanging –**

Exhibit a 4 or 9 block quilt or quilted wall hanging. Each block should measure 12 inches by 12 inches for the 4-block version or 9 inches by 9 inches for the 9-block version. Finished project must include appliqué and/or triangle pieces with sashing and/or borders. Finished quilt not to exceed 36 inches by 36 inches. Attach a completed Needlework Project Card to the exhibit with a safety pin.

Quilting technique: Hand or machine cross hatching, stitching in the ditch, or echo/outline quilting.

Option for finishing edges: Binding with mitered corners, hanging sleeve optional.

835 **Advanced: Creative Quilt or Quilted Wall Hanging –**

Exhibit a creative quilt, minimum finished size 24 inches by 24 inches, maximum size 48 inches by 48 inches. Quilt top should include advanced piecing techniques joined by hand and/or machine that may include dimensional pieces, appliqué, foundation piecing, English paper piecing, miniature scale, and/or landscape design. Attach a completed Needlework Project Card to the exhibit with a safety pin.

Quilting technique: Hand or machine stippling or patterned/stenciled motifs

Option for finishing edges: Binding with mitered corners, hanging sleeve optional.

4-H FOODS EXHIBITS

1. All exhibits must be entered *on plain paper plates and in a Zipper- bag.*
2. **No food will be returned.**
3. **A county may submit one entry per class for the state fair(1 county champion per class)**
4. **A member may enter up to 3 classes within the same level in the Foods Division. (This means: a member's name could appear up to 3 times in the Foods Division**
5. Entries are to be made using recipes in the **4-H Cooperative Curriculum Service (4-HCCS)** project manual.

Level A: Six Easy Bites (Use recipe at www.Kentucky4-H.org under State Fair Recipes.)

- 841- Four (4) drop, Colossal cookies (pg.34) (size of cookies: cookies may be ¼ cup portions as specified in the recipe or 1/8 cup portions which produce smaller cookies)
- 842- Four (4) home-made brownies (2" square- no corner pieces)
- 843- Four (4) chocolate chip muffins or Bran Muffins
- 844- Four (4) two-inch square granola bars
- 845- **Four (4) cornmeal muffins.**

Level B: Tasty Tidbits (Use recipe at www.Kentucky4-H.org under State Fair Recipes.)

- 846- 1 eight inch (8) round layer chocolate cake, made with oil, no icing
- 847- Four (4) pretzels, (may be rolled, twisted, or curved)
- 848- Four (4) rolled baking powder biscuits (pg. 38) (Do not use Australian biscuit recipe)
- 849- Four (4) cheese straws (4-H web site)
- 850- **Four (4) whole wheat muffins or Bran Muffins. (p.8)**

Level C: You're the Chef (Use recipe at www.Kentucky4-H.org under State Fair Recipes.)

- 851- One-half loaf banana bread
- 852- One quarter (1/4) tea ring bread (yeast dough)
- 853- Four (4) breadsticks (not twisted)
- 854- **Four (4) whole wheat yeast rolls.**
- 855- **Invent a nutritious snack which does not require refrigeration (pg. 48-49). For the fair, prepare a sample of the snack (2 servings) and place it in a re-closeable bag. Attach the recipe used and explain why this snack is a nutritious choice. Write this information on 8.5" X 11" paper and attach it to the sample.**

Level D: Foodworks (Use recipe at www.Kentucky4-H.org under State Fair Recipes.)

- 856- One whole, double crust apple pie
- 857- Four (4) two-inch diamond shaped of baklava
- 858- One-half apple cake (4-H web site)
- 859- **Prepare one dish which can be included in the menu for an event or occasion you plan to cater (pg. 46-47, Level D: Foodworks project book). Select a product which can be prepared in advance and does not require refrigeration. For the fair, prepare a sample of the product (2 servings is enough) and place it in a re-closeable, zip-type bag. Attach the recipe used, a description of the type of occasion being catered, and a menu of all foods to be served at the event. Write this information on 8.5" X 11" paper and attach it to the sample**

- 860 Two (2) brownies using the original recipe and (2) brownies altered to make a healthier product (use the recipes at www.Kentucky4-H.org, under “State Fair Recipes”) Make one batch of brownies using the original recipe. Make a second batch of brownies using one of the altered recipes. Label the bag of brownies made by the original recipe as “Original” and the bag of those made from the altered recipe as “Altered—Moderate Fat” or “Altered—Low Fat.” On 11” X 8.5” paper, write a comparison of the two products; describe the differences in appearance, taste, nutritive value, quality and tell how the altered product might benefit members of your family. Place the two bags of brownies into a larger re-closeable bag, insert the comparison report and close the bag.

FOOD PRESERVATION

A member may enter one class in the Food Preservation division.

1. Each jar must be labeled with official canning label. Labels are included in labeling instructions. Indicate on label date product was canned. **Use labels updated after 2000.**
2. Labeling Packaged items: Foods in the frozen food categories should be in moisture – and – vapor-resistant containers designed for freezing. Include date of freezing.
3. Place tape with class number on top of jar.
4. Food Preservation jars must be clear, clean **STANDARD** jars specifically designed for home canning. **Mayonnaise jars and non-standard jars will be disqualified.**
5. Two-piece screw bands and lids specifically designed for home canning should be left on containers until entered at the fair. **Judges will remove screw bands for judging purposes.**
6. Use correct canning method indicated in University of Kentucky “Guide to Home Canning.” **Jars not processed by the correct methods will be disqualified. Open kettle processing is not acceptable for any product.**
7. All food preservation entries must be prepared with raw products. Re-canning of commercially processed foods will be disqualified.

Level A: Six Easy Bites Project Book

- 861 Package prepared for freezer-Prepare a package of baked Colossal Cookies, using appropriate freezing techniques (pg. 34-35 of Level A: Six Easy Bites project book) Cookies may be made smaller (in 1/8 cup portions rather than ¼ cup portions) in order to fit containers easily available in stores. Include enough cookies to appropriately fill the container.

Level B: Tasty Tidbits Project Book

- 862 Tasty Tidbits Twelve (12) banana chips using appropriate drying technique. Place in plastic container or zip-type re-closeable bag.

Level C: You're the Chef Project Book

- 863 One (1) pint of pickle relish (pg. 44) or zesty salsa (pg.40) canned according to the instructions in Level C: You're the Chef project book.

Level D: Foodworks Project Book

- 864 One (1) half-pint jar cooked jelly (any fruit) (pg. 41-43), canned according to the instructions in Level D: Foodworks project book. (Jams and preserves are not appropriate entries.) Write the type of fruit used on the canning label.
- 865 One (1) pint of green beans, canned according to the instructions in Level D: Foodworks project book, pp. 38-40.

HOME ENVIRONMENT

1. **A county may submit one entry per class. A member** may enter up to 3 classes within the same unit in the Home Environment Division. (This means: a member's name could appear in the same level up to 3 times)
2. The work on the entry must be done by the 4-H member since the **2009** County Fair.
3. Wall hangings must be ready to hang with appropriate hardware attached.
4. Table setting exhibit for Unit III must be packed to prevent breakage and loss. Each item in the display must be labeled. We are not responsible for loss or breakage. No silverware please. Refinished item refers to an Item already in use which has been given a new finish of paint or a type of seal.
5. **Exhibits in Unites III, IV and Changing Spaces, must include a one-page, front only narrative or the project will be disqualified.**

UNIT I EXHIBITS from Exploring Your Home project book

- 887 - Color Collage - (activity 3 from Unit I project book). **This must be mounted on mat board or foam core board.**
- 888 - Texture Collage or Rubbing - select from Activity 1 or 2 from Unit I project book. **Mount collage or rubbing on mat board or foam core board.**
- 889 - Natural finish (grain shows through) applied to small wood object (pp. 13-14) **Apply a natural finish such as tung oil or penetrating seal to a small wood object such as a bowl, tray, cutting board, board game or box. Judging emphasis will be on how well the finish has been applied, not on the construction of wood object). Items finished with paint do not fit in this class.**
- 890 - Simple, small **cloth item for the home created with no machine stitching.** Examples knotted pillow with no applied design, place mats, draped valance with accompanying photo showing end result. **Unacceptable: purses, tote bags, backpacks, duffle bags.**
- 891 - Simple, small cloth **item for the home created using minimal machine stitching.** Examples include plain pillow (**No applied design**), fringed tablecloth, place mats and napkins, laundry bag, valance. . **Unacceptable: purses, tote bags, backpacks, duffle bags.**
- 892 - **Wastebasket**
- 893 - **Pin-up** (bulletin) board.

UNIT II

- 894 - **Simple wood item** refinished by the 4-H member. Item should have straight lines with no elaborate carvings or turnings. (The idea is to learn how to apply a new finish such as paint, stain, varnish, polyurethane, etc. to a wooden furnishing that's already in use.) Examples: refinish a foot stool, children's furniture, small box, tray, picture frame, book shelves and plant stand.
- 895 - **Small item for the home created using a sewing machine.** Examples hemmed tablecloth or

table runner, wall hanging, pillow, and flat-panel hemmed curtains. . **Unacceptable: purses, tote bags, backpacks, duffle bags.**

- 896 - **Desk Set, made up of three of more items.**(Examples: blotter, pencil holder, letter box, notebook, etc).

UNIT III - ALL EXHIBITS MUST INCLUDE DOCUMENTATION SPECIFIED BELOW

- 897 - **Accessory for the home**

Created by the 4-H member - This exhibit is to be made up of two parts: 1) the accessory and 2) a sheet or folder of documentation. Documentation is to include: a sketch or photo to show how the accessory is used in the home and a description of how the design and colors fit in with the other furnishings and color used in the home. Examples:-stitchery or appliqué wall hanging, latch hook items, pillow with applied design (stitchery, appliqué or other media), rug, picture in appropriate frame and ready to hang.

- 898 - **Table setting,**

This exhibit is to be made up of two parts: 1) the table setting and 2) a color photo of the table setting showing how it should be arranged. Include centerpiece, plate, beverage container(s) and table linen appropriate to theme or event chosen by 4-H member (pp. 11-13). Do not include flatware (knife, fork or spoon). Individual items included in the table setting may by but are not required to be made by the 4-H'er. To insure that all pieces get returned to the member, write the name and county of the exhibitor on tape and place it on every part of the table setting in a location hidden to the public when exhibited at the fair.

- 899 - **Piece of furniture** refinished (stripped, sanded, and painted or stained/sealed) by the 4-H member (pp. 16-20) - This exhibit is to be made up of two parts: 1) the furniture and 2) a “before” picture securely attached. Examples: rocker, table, large chair or chest.

- 900 - **Old or discarded item made useful in a new way as a home accessory** (p. 20) - This exhibit is to be made up of two parts: 1) the accessory and 2) a sheet or folder of documentation. Documentation is to include a “before” photo; an explanation of how the item was made useful again in a new way; Materials used, cost and time involved in project. Examples: old silverware flattened and made into wind chimes, scrap wood pieces made into wall art, old lace doily attached to a pillow or framed, old tool box cleaned up and made into a TV stand.

UNIT IV- ALL EXHIBITS MUST INCLUDE DOCUMENTATION SPECIFIED BELOW

- 901 - **An accessory for the home made with original or adapted design**

This exhibit is to be made up of two parts: 1) the accessory and 2) a sheet or folder of documentation. Documentation is to include an explanation of how the item was created/adapted and a description of how and where item is used in the home. Examples latch hook item; pillow with stitchery design; wall hanging of natural dyed yarns or drawing with mat and finished or refinished frame.

- 902 - **Heritage item, refinished, restored, or made by the 4-H member-**

This exhibit is to be made up of two parts: 1) the item and 2) a sheet or folder of documentation. Documentation is to include information on the history or meaning of the item to the member, how the item was refinished, restored, or made by the member, and how it is used in the home. Examples include antique or collectible furniture, memory box, scrapbook of family history (Reflect family history/home/house/farm/land of three or more generations), quilt with heritage design, wall hanging showing family tree.

903 - **Purchased article selected by 4-H member to solve a home decorating problem.**
This exhibit is to be made up of two parts: 1) the purchased article and 2) a folder of documentation. Documentation is to include a description of the problem to be solved, alternatives considered in the solution of the problem, how the plan was carried out, resources used (time, money) and member's evaluation of the results (satisfaction with purchased article, how article is used in the home), and photos illustrating the before and after effect. Examples include wall decoration, lamp, vase, storage item, desk accessories, bedspread, rug, table linens, pillow, and draperies.

904 - **A cloth article made by the 4-Her showing a major home improvement:**
This exhibit is to be made up of two parts: 1) the cloth article and 2) a folder of documentation. Documentation is to include a written description, "before" and "after" pictures/showing how cloth article is used in home, other colors used in room, time and costs involved, and care required. Examples: bedspread, quilt, window treatment and boxed bench pad. **Unacceptable: purses, tote bags, backpacks, duffle bags.**

Self-Directed ADVANCED PROJECT –the intent of the following classes is to give members an opportunity to put everything they have learned in the home environment projects into practice.

905 - **Furniture,**
Which has been, refinished, reupholstered, recovered, recycled, reused or remodeled.
Exhibit is to be made up of two pieces: 1) the piece of furniture and 2) a folder describing the original condition of the furniture (include a picture if possible), work required in completing project, time and cost involved, and how item is used in the home. DO NOT INCLUDE NEWLY CONSTRUCTED FURNITURE.

906 - **Design Experience.**
Create a plan for or actually complete a design experience. The exhibit is to be made up of two pieces: 1) a home furnishing item which is representative of the design experience (item may be made by the member or purchased) and 2) a folder or notebook describing the plan. Examples of project ideas: a plan for redecorating a room; creation of an accessory item using an original design of 4-H member; notebook with pictures and descriptions of architectural styles used in Kentucky homes. ,

907 - **Heritage Experience –**
Complete a heritage project. The exhibit is to be made up of two pieces: 1) an item representative of the heritage experience and 2) a folder or notebook describing the overall experience, the significance of the project to your family. Examples of project ideas: Restoration of a family heirloom (could include caning, reseating, etc.) including who it belonged to and the significance to the family; study of furniture styles including pictures and history; study of old buildings in the community including photos and descriptions of the architectural significance, period of history, uses of the buildings; create an item after learning a heritage or craft skill...especially from an older family member or friend and describe how skill was learned, how interest was stimulated and how you will use item and skill.

908- **Major Home Improvement.**
Complete a major home improvement project. The exhibit is to be made up of a notebook which is the project, tell whether project was an individual project or a group or family project, describe the do-it-yourself skills learned, time and cost involved. Include before, during, and after photographs, if possible. Examples: improve storage areas in the house or garage; paint the house; wallpaper and decorate a room; remodel the basement.

CHANGING SPACES:

909- Room Floor Plan.

This exhibit is to be made up of two parts: 1) a mounted printout of a room and 2) folder of the documentation described below. Use the Better Homes and Garden web site www.bhg.com/decorating/arrange-a-room/ or similar software to draw a room (scale: 1 square = 1 foot). Include a door(s), window(s), and furniture. Print in color or black and white, (Minimum size 8 ½ x 11 inches, Maximum size 11 x 17 inches). Mount the printout on mat board or foam core board. Documentation should include answers to these questions: 1. Is the room you have drawn similar to a room in your house? What are its dimensions? How many square feet are in the room? 2. Did you have problems with the web site or software? If so, how did you solve them? 3. Tell about how you worked with the items in your room such as walls, windows, doors and furniture

910- House Floor Plan

This exhibit is to be made up of two parts: 1) mounted printout of house plan and 2) folder of the documentation described below. Use any software program to draw a house plan. Include bedroom(s), bath(s), living space, garage, door(s) and window(s). Print in color or black and white: (Minimum size 8 ½ x 11 inches. Maximum size 11 x 17 inches.). Mount the printout on mat board or foam core board. Documentation should include answers to these questions: 1. Does your floor plan resemble the house you live in? If not, did you look at other floor plans for inspiration? What type of roof does your house have? 2. Did you consider how a family member who is disabled (for instance, a wheelchair user) might get around in your home? 3. Describe any problems you had with the software and how you solved them. Tell how you worked with additional items required to create a floor plan.

911- Presentation Board – Color Scheme:

This exhibit is to be made up of two parts: 1) a presentation board as described below and 2) a folder of the documentation described below. Using the Mississippi web site, (http://msucare.com/4h_Youth/interior_design/index.html) create a presentation board (color scheme only) for any room in the home. Mount swatches of the actual fabric, wall, and floor samples or use a web site to download color copies or substitute magazine or scrapbook paper to represent these items on mat or foam core board. The white board should be 11 x 18 inches and the black board should be 13 x 20 inches. In the folder, describe the person who lives in the room and the decisions required in selecting the color scheme

912 - Presentation Board – Bedroom:

This exhibit is to be made up of two parts: 1) a presentation board as described below and 2) a folder of the documentation described below. Kentucky 4-H Clover

General rules applying to all 4-H Centennial classes:

7. Junior division includes ages 9-13; Senior division includes ages 14-18.

Market animals must be on the fairgrounds and weighed in
By 12:00 Noon.

Livestock Judging/Stockman's Contest -1:00 p.m.

Completion Show – 2:00 p.m.

Buyers Picnic- 5:30 p.m.

Youth Sale- 6:30 p.m.

Showmanship Classes will be offered for each species.

**Members must accompany animals at time of weigh-in
And Turn In project record book.**

1. The show & sale is open to any Hardin County youth, 4-H & FFA, (9-18 yrs of age as of January 1st of the current year) who lives and/or attends school in Hardin County and is currently enrolled in the Hardin County 4-H program.
2. **The exhibitor must meet the required (6) educational hours as stated by the state 4-H livestock certification program and prior to the Hardin County KUIP validation dates.**
3. All animals must be owned by the 4-H or FFA member, weighed and tagged with proper KUIP or county tags. Deadline as set by the KY Dept of Shows and Fairs: **Steers** (5 head max) March 31 ; **Lambs** (6 head max), **Goats** (6 head max) and **Hogs** (10 hd. max) May 31.
 - **Steers KUIP** tagging date - **(3:30 – 7:30pm) Friday, March 27th** - Hardin Co. Fairgrounds (this will be multi-county) ~ **ALL STEERS MUST BE HALTER BROKE**. If determined by a YPCS board member that animal is not suitably halter broke, it will not be KUIP tagged.
 - **Hogs, Lambs & Goats KUIP** tagging date - **(3:30 – 7:30pm) Friday, May 1st** Hardin County Fairgrounds (this will be multi-county)
 - All market animals will be tagged with a single R.F.I.D. (Radio Frequency Identification) tag which will be used as the K.U.I.P. tag. This tag, when applied, also takes an ear tissue sample which will be used for the DNA sample. The tagging fee will be increased to \$4 per head.
 - Market lambs and market goats must possess a scrapie tag at the time of validation. The scrapie tag number will be recorded on the validation form.
 - Only those animals with proper KUIP tags will be eligible to participate in county fairs, district shows, preview shows, Junior Livestock Expos & must have been collected for DNA testing to be eligible for KY State Fair.
 - **Each animal will be tagged in the exhibitors name at the county level.**

- Parents not present at official KUIP tagging must sign “Waiver and Hold Harmless” agreement (see attached sheet)
4. In the market goat division: *“Horns will be optional, but must be tipped. Tipped is defined as the end of the horn being squared off to 1/2 inch in diameter.”*
 5. On the day of the show, any animal the YPCS committee considers as a hazard to exhibitors, spectators etc. will be excused from the show and ineligible for class placement and premiums.
 6. **NO PETS ALLOWED IN BARN** – only those animals being exhibited.
 7. All animals being exhibited must be owned and under the continuous care of the exhibitor from the initial tagging and weigh-in date and available for inspection at anytime there after. Exhibitors must show his/her own animal.
 8. All animals will be required to have appropriate health papers and must be in the members possession at the time of weigh-in. All animals must comply with State Livestock Health Requirements, including drug and feed additives and withholding periods.
 9. **Each member will be allowed to show a total of (4) animals with only ONE (1) of those animals being allowed in the sale and a maximum of (2) animals per species.** You are not required to sell your animal at the county fair, however the following rules will apply:
 - Under the DNA/KUIP guidelines, all market animals shown and participating in the premium auction at the county level are eligible to participate at the State Fair providing the animal does not change ownership and all other state fair entry guidelines are met.
 - To be eligible to compete at the KY State Fair, all 4-H/FFA market steers, goats & lambs must compete in one of the pre-district shows or junior livestock shows sponsored by the KY Dept of Agriculture which are subject to the KDA 4-H/FFA guidelines. Market hogs are exempt from these shows due to requirements for maintaining a closed herd. Novice exhibitors of market animals are not required to attend a qualifying show to be eligible to compete at the KY State Fair.
 10. Market animals must meet the following weight requirements upon arrival:
 - Swine** - 200 lbs. min. (weights will be used to make light/med/heavy wt classes)
 - Steers** - no weight limit **but must weigh a minimum of 600 lbs at time of the initial March Weigh In.** (weight and/or hip height maybe used to break classes)
 - Lambs** - must weigh a **minimum of 90 lbs** at county fair weigh - in
 - Goats** - will be shown by weight and must weigh minimum of 40# at county fair weigh-in, be born after August 15, 2008 and must be castrated (surgically removed or banded) and healed prior to show.
 11. Market **animals** must be **on the fairgrounds** & **weighed** in between 9:00 – 11:00am, **Tuesday, July 7th.**

Members **must accompany their animals** at time of weigh in and **turn in project record books.**

A **Livestock Judging** Contest will begin at **1:00 p.m.**

Youth Project Completion Show at **2:00 p.m.** (Showmanship classes / each species)

Buyers Picnic will begin at **5:30 p.m.**

Youth Project Completion Sale is scheduled to begin at **6:30 p.m.**

12. Each animal will have a base selling price relative to it's weight, estimated carcass grade and current market price for the week in which the sale is held. A representative from the stockyard will determine all base prices.
- Exhibitors with more than (1) animal in the show, will be allowed to sell that animal at the pre-determined base selling price should they wish to do so
 - It is recommended that exhibitors and a parent be present at the time animals are given their respective base market price.
 - It is important to remember that animals raised under this program are for "market/slaughter" purposes only and should not be returning to the farm as a breeding animal.
13. Sale order will be as follows: 1st Grand Champion and 2nd Reserve Grand Champion for each respective species. **The grand champion animal will be sold to the highest bidder. The reserve champion price may not exceed the price of the grand champion animal. The sale price of all other animals may not exceed the price given for the reserve champion in each respective species.**
14. All animals need to be clipped in accordance with the respective district show rules. When a class is called exhibitors must be ready to enter the ring. Show order will be as follows:
- Swine Showmanship followed by Market Swine Classes
 - Goat Showmanship followed by Market Goat Classes
 - Sheep Showmanship followed by Market Lamb Classes
 - Steer Showmanship followed by Market Steer Classes
15. A selling fee based on total premium bids divided by total expenses (**including cost of awards**), will be deducted from final checks.
16. An average daily gain (ADG) award will be awarded to steer and swine exhibitors with an overall highest gain being awarded to lamb and goat exhibitors.
17. A **Supreme Exhibitor Award**, \$250 cash premium, will be given to an individual in each species (Goats, Hogs, Lambs & Steers) with the highest overall points based on a 3 prong point system (1/3 animal, 1/3 judging & 1/3 showmanship). Points will be awarded as follows:

Animal Placing, Showmanship and Judging Points

- 1st Place 10 points
- 2nd Place 9 points
- 3rd Place 8 points
- 4th Place 7 points
- 5th Place 6 points
- 6th Place 5 points
- 7th Place 4 points
- 8th Place 3 points
- 9th Place 2 points
- 10th Place and lower 1 point

Tie Breakers

- Individual Judging Score Total Points
- Showmanship Placing
- Animal Placing

Only one Supreme Exhibitor Award per contestant.

18. An **Outstanding Project Record Book Award**, \$100 cash premium for the **champion** and \$50 cash premium for the **reserve champion** will be given in each age division (junior and senior) with the highest scoring project record book submitted by the September 1st deadline of the current program year. Judging will be done ASAP following the deadline on a specific date by a group of adults and/or volunteer leaders.

Upon completion of the YPCS judging, participants may submit their project book in the achievement record format to be eligible for county and district competition.

19. Youth Project Completion Sale **project record books, (1) per species, must be kept on all market animals and presented at your market animal weigh-in.** These records will be reviewed and **should be up-to-date, (including sponsor contact page).** **NO RECORDS, NO SHOW.**
20. **ALL PARTICIPANTS** and parents are encouraged to **attend a Show Barn “Clean-Up”** at 10:00am the Saturday (July 5th) prior to opening of Hardin County Fair.
21. **Sale checks** are usually distributed 3-4 weeks after the sale **and** upon **submitting a completed project record book (1) per species and buyer “Thank You” notes** (addressed & stamped) into the extension office **no later than the September 1st.** Failure to submit a record book or “Thank You” notes will disqualify you from participating in future Youth Project Completion Shows and Sales.
22. Any disputes and/or actions by participants that is deemed not to be in the best interest of the show, sale or project animal (including poor sportsmanship) may result in automatic disqualification if so recommended by the youth livestock advisory committee.
23. Exhibitors must contact a minimum of **(6) sponsors** as outline in their record books **It also highly recommended that each exhibitor collect a minimum of \$100 from sponsors toward the sale of your animal.**

Tuesday, July 7, 2009 – 1:00 p.m. - Livestock Barn
Trophies furnished by: Hardin County Cattlemen’s Association

1. The Hardin County Fair Youth Livestock judging contest is open only to Hardin County 4-H and FFA members.
2. The contest will be held on Tuesday, July 7, 2009 prior to the Youth Project Completion Show. **Contestants wishing to participate in this event should be on the grounds at least one hour prior to the show.**
3. The contest will consist of live animal evaluation (beef and/or swine), and non-traditional classes such as identification of breeds, parts, feeds, EPD’s, etc. (beef, sheep, swine).
4. Score cards will be furnished to all participants. Questions may be asked on some classes of live animal evaluation to break any tie scores.
5. Age divisions will be juniors (9-13 years of age) and seniors (14-19 years of age).
6. Ribbons will be given to all participants. Premiums will be paid to the top 5 individuals for each age division in both 4-H and FFA.
